DIRECTOR


Hello everyone. The first thing to say "from the Chair" is that our last production (Alan Bennett's *Habeas Corpus*) was a sell-out. Yes, we were 100% full throughout the eight day run. If this continues we shall have to expand the theatre or run for longer! Many thanks to Gini Comyns and her cast and crew for such a wonderful result. This is really something for the Little Theatre to be proud of, and word-of-mouth will have raised our profile in the town - and beyond.

However, any production is only ever with us for a short time and it isn't long before the title is removed from above the door, the scenery is dismantled and the next play is cast and in rehearsal. This May will see the staging of *Hobson's Choice* directed by Stella Dench, a perennial favourite from "up north" that I am sure will delight our audiences.

While all the artistic business has been in full flow, the management committee has been thrashing out a few necessary updates to our rule book. #### OUR NEXT PRODUCTION - HOBSON'S CHOICE by Harold Brighouse



STELLA DENCH DIRECTS THIS ageless comedy, a classic piece of British Theatre, by Harold Brighouse, which is being staged at Seaford for the first time.

Henry Horatio Hobson is a widower and boot shop proprietor in Salford. He has three unmarried daughters who all work for him, unpaid, alongside his talented but under-appreciated staff. Hobson himself enjoys a leisurely life drinking with his pals and is quite happy with this arrangement until his shrewd elder daughter, Maggie, spots an opportunity, in the shape of Hobson's diffident but talented cobbler, Willie Mossop, to change the status quo and secure her financial future.

Henry Hobson is played by Douglas Wragg, making his Seaford debut, as is Peter Barnes in the role of Fred Beenstock, and they

appear alongside the acting talents of Roland Boorman, Ann Mabey, Jenny Humphries, Lindsey Holledge, Chris Church, Mary Young, Dennis Picott, John Hamilton, Wendy Picott and Stephen Newberry.

The show opens on Friday 11 May 2012 and runs through to the following Saturday 19 May, with evening performances from 7.45pm and a matinee on Saturday 12 May at 2.30pm.

**Theatre Clean Up** Seaford Little Theatre from 2.30pm



## Seaford Little Theatre Notice of Extraordinary General Meeting to be held on Friday, 27<sup>th</sup> April at 7.30.pm. at the theatre

#### Agenda

- 1. Apologies for Absence
- 2. To consider changes to the Rules of the Society proposed by the Management Committee. See (a) to (f) below. \*
- 3. Any Other Business

The committee reviewed proposed changes to the rules of the society following from the AGM last October. It was agreed that changes were necessary, with some of the opinion that the whole document should be rewritten by a sub-committee using a model constitution. This would take some months and it was agreed to suggest amendments to the current document for presentation to the membership in April, in the interim. It was agreed that the following changes should be put to the membership at the Extraordinary General Meeting in April:

- \* a) Rule 8 to read:
  - "8a) The management of the society as a whole shall be vested in a Management Committee. This committee shall be elected annually, with two exceptions:
    - i. The Chairman may hold office for no more than three successive years.
    - ii. The President may be elected for a longer period.
  - 8b) The constitution of the Management Committee shall be as follows:
    - The Honorary Executive Officers referred to in Rule 7 ex officio with voting powers.
    - Four other members of the Society elected for 2 years, two of whom shall retire annually in rotation, but be eligible for re-election.
  - 8c) Nomination forms for officers and committee members shall be sent to members with the agenda for the AGM. These must be signed by the nominator, seconder and nominee, and returned to the Hon. Secretary prior to the start of the AGM.
  - 8d) the present 8b
  - 8e) the present 8c amended to "The Committee shall have the power to co-opt, but co-opted members shall not be Trustees."
  - b) It was agreed to suggest merging Rule 19 into Rule 5 as it covers the same information on non payment of subscriptions.
  - c) It was also suggested that the following wording be added to Rule 10: "Committee Meetings shall be chaired by the Chairman, or the Vice-Chairman in the absence of the Chairman."
  - d) To clear the confusion caused by members' eligibility to vote at the AGM, it was agreed to add a clause to Rule 17 to read: c) Members paying their subscription before the AGM in October are eligible to vote at that AGM. All subscriptions for the following year become due as from 31<sup>st</sup> October, but can be paid after the AGM. Members paying after the AGM or after 31<sup>st</sup> October are paying the subscription for the following twelve months and voting at the AGM of that year.
  - e) It was agreed to allow Proxy Votes at the AGM. This would be put in as the replacement Rule 19 to read: A member can appoint a proxy to vote on his/ her behalf at an AGM. A proxy must be a fully paid up member of the society and accept responsibility to act as proxy on behalf of another member. Proxy voting forms will be sent to any member unable to attend the AGM, upon request to the Hon. Secretary.
  - f) It was agreed to change Rule 26b) to read: Casting Committee: This committee shall consist of the Director, a member of the Management Committee and one other member with considerable stage experience, none of whom are eligible to be cast.
